Funding for Priest Lake Management Infrastructure Improvements

Dear Governor Otter,

In February of 2015 the Priest Lake Breakwater Committee, as an advisory committee to Bonner County Parks and Recreation, met for the purpose of finding a solution to the deterioration of the Thorofare Breakwater and the resulting difficulties in accessing the Upper Priest Lake. It was obvious that if there was no action taken this rare and valuable recreational asset would end its original purpose of being available to all. The Thorofare provides access for literally thousands every spring, summer and fall. Generations of tourists, locals, and seasonal residents have traveled the Thorofare and consider it an annual pilgrimage demanded by its primitive and serene experience. It would be difficult to find a boat, a canoe or kayak that has not made multiple trips to the Upper Lake. As "Old Faithful" is to Yellowstone Park, our Upper Lake and Thorofare are to Priest Lake and its community.

It was clear to our committee that the loss of this waterway would be a serious blow to our lake's attraction power to tourists as well as the residents. All are here because of the lake! It is what supports the resorts, marinas, docks, contractors, real estate, hotels, motels, grocery stores and gas stations. If the Thorofare becomes impassable to powered watercrafts it diminishes all of the above. With the economic component of waterways for Bonner County being \$35 Million, the Priest Lake contribution to that component would be significantly shrunken should we lose the Thorofare and Upper Lake. It would be a permanent loss never to be recovered.

The Breakwater Committee is made up of 8 Priest Lake volunteers. It consists of a wide cross-section of backgrounds but they all call themselves "Priest Lakers". We have contractors, resort owners, an attorney, an Idaho State employee, a couple of insurance people and all are either residents or summer residents.

The 2015 Committee recognized that the need for repairing or replacing the Breakwater would require meaningful resources beyond what our community could provide but, we could do our

best to demonstrate the critical need to "Save the Thorofare". We decided to initiate a project to get as much financial support as we could from everyone possible. Priest Lake is the home of a very successful Charitable 501 C-3 organization, "Priest Lake People Helping People, Inc." (PLPHL). We partnered with PLPHP who set up a totally segregated account to receive tax deductible donations from any source we could find. All donations were identified individually and should we fail to rescue the Thorofare we would be able to refund their support or redirect it as they choose.

We set up a website, hired a social media manager and began an aggressive approach process including phone and personal solicitation. We have been more successful than we anticipated for the size of our community. To date we have received cash and pledges totaling \$61,841. Our project has pledged \$20,000 to Bonner County as a part of the allocated dredging cost of \$110,000. The incurred expenses of our project has an expense ratio of less than .5%. We have had very nice donations from all of the resorts. We have strong help from a wide range of developments i.e. Burlington Northern-Santa Fe Railroad, The Idaho Forest Group and the Smith-Barbieri Progressive Fund. Attached is a page from our Facebook page listing both our business and personal supporters.

Our funds will be a small part of what the overall budget that "Saving the Thorofare" requires but, it does vividly demonstrate how important this destination resource is to our entire community. Through our social media and regular updates on our progress we have always promised our supporters that their contributions will be used as part of funding from other sources. We have, since the beginning, kept strict accounting on every individual cash donation and pledge. As one generous local business person commented at the time of their pledge. "We will write the check when we see dirt being moved!" Our committee and every supporter of our project is committed to putting our funds to work to "Save the Thorofare". Hopefully we can be a partner with the State and other resources to preserve access to our jewel, Upper Priest Lake.
